RESPONSE TO SGX-ST'S QUERY REGARDING ANNUAL REPORT

In response to the query raised by Singapore Exchange Securities Trading Limited ("SGX-ST") in its email of 16 April 2012 in connection with the Company's Annual Report for the financial year ended 31 December 2011, the Board of Directors of City Developments Limited (the "Company") wishes to clarify as follows:

Extract of SGX-ST's Query

"Rule 1207(10) of the Listing Manual requires disclosure in the Annual Report on the opinion of the board with the concurrence of the audit committee on the adequacy of the internal controls, addressing financial, operational and compliance risks.

For the purpose of complying with Listing Rule 1207(10), please note that "absence of evidence to the contrary" disclaimer is not allowed in the opinion.

We note that the confirmation provided in your annual report is not consistent with the guideline stated above. Hence, please provide a clean opinion that is in compliance with Listing Rule 1207(10)."

Company's Response

The Company refers to the statements made on the Group's internal controls as set out under the section entitled "Principle 12: Internal Controls" on page 38 of its Annual Report and confirms the following opinion, in compliance with Listing Rule 1207(10):
