PROFIT WARNING ANNOUNCEMENT

This announcement is made in accordance with Rule 13.09 of the Listing Rules and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The Board wishes to inform the shareholders of the Company and potential investors that the Group expects to record a loss of about HK\$19 million for the year ended 31 December 2014 subject to the finalisation and necessary adjustments to the financial statements of the Group. The Board considers that the loss was mainly attributable to a decrease in the net unrealised gains arising from fair value readjustments of the Group's trading securities and an increase in the net unrealised foreign exchange losses as a result of the unfavourable movements in the Group's currency portfolio as at reporting date.

Shareholders and potential investors should exercise caution when dealing in the securities of the Company.

This announcement is made by City e-Solutions Limited (the "Company"), and together with its subsidiaries, joint arrangements and associates (the "Group") pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the unaudited financial results announcement of the Company for the nine months ended 30 September 2014 published on 11 November 2014 whereby it was announced that the Group recorded a loss for the period of HK\$11.6

million as compared with a profit of HK\$2.6 million in the previous corresponding period (the “September 2014 Results Announcement”). Further to the September 2014 Results Announcement, the board of directors of the Company (the “Board”) wishes to inform the shareholders of the Company and potential investors that, based on the preliminary assessment of the available unaudited financial information of the Group for the year ended 31 December 2014, the Group expects to increase the loss to about HK\$19 million for the year ended 31 December 2014 as compared to a profit of HK\$15.9 million for the corresponding year in 2013. The Board considers that the loss was mainly attributable to a decrease in net unrealised gains arising from fair value readjustments of the Group’s trading securities and an increase in the net unrealised foreign exchange losses as a result of the unfavourable movements in the Group’s currency portfolio as at reporting date.

The information contained in this announcement is based on information currently available to the Group and a preliminary assessment of the management accounts of the Group by the management of the Company. It is not based on any figures or information that has been audited or reviewed by the Company’s auditors and remains subject to finalisation and necessary adjustments. Further details of the Group’s financial information will be disclosed in the annual results announcement, which will be published on or about 13 February 2015 pursuant to the requirements of the Listing Rules.
