As announced earlier this morning by the Minister for Earthquake Recovery and the Canterbury Earthquake Recovery Authority (CERA), demolition work on the Copthorne Hotel Christchurch City, a leased property, will be commencing in the very near future. CERA has confirmed that a contract for the works has now been awarded to Leighs Engineering and that the demolition will be by mechanical means. The work is expected to be completed by mid-November this year.
