1. The board of directors ("**Board**") of First Sponsor Group Limited ("**Company**") refers to the announcements dated 3 September 2020 ("**3 September Announcement**") and 8 September 2020 issued by the Company.

Pursuant to Rule 324(1) of the listing manual of the SGX-ST, the Board wishes to announce that between 9 September 2020 and the date of this Announcement, an additional S\$7,788,246.70 in aggregate principal amount of Series 2 Convertible Securities, representing approximately 5.3 per cent. of the Initial Aggregate Principal Amount, have been converted into Ordinary Shares and cancelled.
3. Accordingly, as at the date of this Announcement, a total of S\$142,997,168.60 in aggregate principal amount of Series 2 Convertible Securities, representing approximately 96.8 per cent. of the Initial Aggregate Principal Amount, have been converted into Ordinary Shares and cancelled.

Holders of the Series 2 Convertible Securities should note that the Company has given notice that it will redeem all, and not some only, of the outstanding Series 2 Convertible Securities on 8 October 2020.
