Notifications on Subsidiaries and Associated Companies

The Board of Directors of City Developments Limited (the “**Company**”) wishes to announce that:

(A) Incorporation of Subsidiaries/Associated Company

(1) Grande Strategic Pte. Ltd., a wholly-owned subsidiary of the Company, has incorporated two wholly-owned subsidiaries, namely Redvale Properties Pte. Ltd. (“**Redvale Properties**”) and Redvale Investments Pte. Ltd. (“**Redvale Investments**”). Information relating to Redvale Properties and Redvale Investments as follows:
