Millennium & Copthorne Hotels plc today announces the retirement of independent non-executive Director, Connal Rankin, for health reasons.

Mr Rankin, 69, was appointed as an independent non-executive Director of the Group in December, 2007, after a distinguished career with HSBC, including the role of Group General Manager of Human Resources between 2000 and 2005.

At Millennium & Copthorne Hotels, Mr. Rankin was Chairman of the Board's Remuneration Committee. Following his retirement, the Group has appointed Alexander Waugh to this role with immediate effect. Mr. Waugh, 47, was appointed as an independent non-executive Director of the Group in June, 2009.

Appointment of Chief Executive Officer

Millennium & Copthorne Hotels Plc is pleased to announce the appointment of Wong Hong Ren as Chief Executive Officer with immediate effect.

Mr. Wong, 59, succeeds Richard Hartman, who will remain on the Group Board as a non-executive Director.

Mr. Wong was made Non-Executive Director of Millennium & Copthorne Hotels Plc after the Group's flotation in 1996 and, since April, 2001, has been Chief Financial Officer and Executive Director. He has served as joint CEO and twice served as Interim CEO, including the eight months prior to Mr. Hartman's appointment in April, 2008. During those periods he demonstrated strong leadership in streamlining the Group's management systems and putting in place many of the cost management and capital expenditure controls that protected the Group from the impact of recession following the 2008 financial crisis. He is a Director of many of the Group's subsidiaries and has a deep working knowledge of the Group's business operations.

Mr. Kwek Leng Beng, Chairman of Millennium & Copthorne Hotels Plc, said:

"Wong Hong Ren emerged as the strongest candidate to fill the position of Group CEO after a prolonged search and many interviews conducted with other potential candidates. The Board believes that Mr. Wong's deep understanding of the Group and its strategy, his disciplined approach to operational management, his keen analytical skills and his outstanding contribution to enhancing the asset value of the Group make him the ideal successor to Richard Hartman. His leadership will provide vital continuity as we execute our existing strategy.

"We have started our search for a new CFO, who will be appointed to the Board, and we expect to announce shortly the appointment of a Group Chief Operating Officer.

"On behalf of the Board, I thank Richard Hartman for his service as CEO. He leaves the role, having placed the Group in a strong trading and financial position, making it well-equipped for future challenges and opportunities. We look forward to working with him in his capacity as a Non-Executive Director as we continue to build on the operating and asset management strengths of the Group."
