(A) Liquidation of Subsidiary Companies

- City Port Development Pte Ltd (with effect from 9 December 2011)
- Edenspring Properties Pte Ltd (with effect from 9 December 2011)
- Frontier Properties Pte. Ltd. (with effect from 9 December 2011)
- North Bridge Commercial Complex Pte Ltd (with effect from 9 December 2011)
- The Corporate Building Pte Ltd (with effect from 9 December 2011)
- The Corporate Office Pte Ltd (with effect from 9 December 2011)
- The Office Chamber Pte Ltd (with effect from 9 December 2011)

(ii) Incorporated in Cayman Islands

- Cosmic Land Limited (with effect from 30 November 2011)

(B) Liquidation and cancellation of Associated Companies

- (i) Taravaca SGPS LDA, an indirect 50% associated company of the Company incorporated in Madeira, was liquidated on 2 December 2011.
- (ii) Yuhwa Investors, LLC, an indirect 50% associated company of the Company incorporated in United States of America, has been officially cancelled by the Office of the Secretary of State, State of Delaware, United States of America on 12 December 2011.

(C) Striking off of Subsidiary and Associated Company

Asterias Villas Pte. Ltd., an indirect wholly-owned subsidiary of the Company, and Cantley Investments Pte. Ltd., a 50% associated company of the Company, have both applied for their respective names to be struck off the register pursuant to Section 344(1) of the Companies Act, Chapter 50.
