(C) Cessation of interest in Subsidiary

The CDL Group had ceased to have interest in Shanghai Fusion Enterprise Management Co., Ltd. 上海涵圣企业管理有限公司 ("Shanghai Fusion"), an indirect wholly-owned subsidiary incorporated in the People's Republic of China and the owner of an office building. Shanghai Fusion was disposed to an unrelated third party for an equity transfer consideration of RMB84,702,278 on 3 February 2026.

MBTM is a wholly-owned subsidiary of M&C REIT, and both MBTM and M&C REIT are indirect wholly-owned subsidiaries of Millennium & Copthorne Hotels Limited, which is in turn a wholly-owned subsidiary of CDL.
