FULL REDEMPTION AND CANCELLATION OF THE SERIES 2 PERPETUAL CONVERTIBLE CAPITAL SECURITIES

1. The board of directors (“**Board**”) of First Sponsor Group Limited (“**Company**”) refers to the announcements dated 3 September 2020, 8 September 2020 and 15 September 2020 (collectively, “**Redemption Announcements**”).

Unless otherwise defined herein or the context otherwise requires, all capitalised terms used in this Announcement shall bear the same meanings ascribed to them in the Redemption Announcements.
