CDL Launches Its First Sculpture under Public Art Tax Incentive Scheme

City Developments Limited (CDL) launches its first public artwork by the river today at The Pier. The first donor to participate in the Public Art Tax Incentive Scheme (PATIS), formerly known as the Public Sculptures Scheme under the National Heritage Board, CDL commissioned the "Reed Sculpture" into a full-sized piece for public display at Robertson Quay.

The "Reed Sculpture" was the winning entry of CDL's inaugural Singapore Sculpture Award in 2003. Conceptualized by Peter Chen, a trained architect and lecturer in Industrial Design, it was slated for the riverfront site at Robertson Quay. The site was chosen to support the government's vision to bring greater vibrancy to the Singapore River through the arts.

Dr Lee Boon Yang, Minister for Information, Communications and the Arts, is the Guest of Honour for the unveiling ceremony to be held this evening.

Mr Kwek Leng Joo, Managing Director of CDL said, "The CDL Singapore Sculpture Award and its support of the Public Art Tax Incentive Scheme are in line with our commitment as a major developer to offer a gracious living environment for Singaporeans. Together with our partners, we hope to help propel Singapore into a global city for the arts as well as to leave a legacy in the cultural and physical landscape of Singapore."

CDL has contributed significantly to Singapore's art scene for more than a decade. Among its various initiatives is the biennial CDL Singapore Sculpture Award, designed to nurture artistic talent and promote public awareness and appreciation for this relatively less developed art form in Singapore, as well as to help enrich Singapore's sculptural landscape. The uniqueness of the sculpture award is that winners have the opportunity to have their works commissioned and installed in a public area.

Donors participating in the PATIS will enjoy double tax deduction for the appraised value of the donated public art, maintenance cost of adopted public art, or installation and maintenance costs of displayed public art. First introduced in 2003, the scheme aims to encourage corporations and individuals to donate, commission, display and maintain public art.

Since 1 April 2006, the scope of PATIS has expanded to include both two and threedimensional public artworks in publicly accessible areas. These can be freestanding installation or integrated into a building facade. More details on PATIS as well as the other tax incentive schemes available for heritage and public art are attached overleaf.

CDL is currently planning to commission the winning sculpture of the 2nd Award to be sited at the upcoming urban park at the City Square Mall. This project has enjoyed the strong support and partnership of the Singapore Art Museum, National Arts Council, Sculpture Square, LASALLE-SIA College of the Arts, Nanyang Academy of Fine Arts and iPreciation Pte Ltd

The 3rd CDL Singapore Sculpture Award, which will be launched in the first quarter of 2007, will see the inclusion of National Parks Board (NParks) to the organizing committee. NParks will be offering suitable public sites amongst its new or existing parks or the new park connectors for the winning works of the Award. This nation-wide competition will provide a platform for participants to customize their sculptural design to enhance the physical landscape of Singapore.

Guests at the launch of "Reed Sculpture" will be offered a sampling of fine cuisine from gourmet restaurants of The Pier, CDL's newest mixed development along the Singapore River. The gastronomic spread include authentic French home-style fare and classical favourites from Brasserie WOLF, canapés from the coffee connoisseur (tcc), chocolate pralines from The Chocolate Factory and modern European cuisine from Reif+James. Adding to the evening's vibrancy are whisky aperitifs from La Maison du Whisky, Phuket Beer from Tasting Notes, as well as a choice selection of beer from Belgian bar and bistro, Brussels Sprouts. Cool chill-out tunes by the jazz trio from Harry's Bar will complete the charming riverside experience. Other tenants at The Pier include Robataya Yoyogi.

Reed Sculpture

Reed Sculpture is the winning piece for the inaugural CDL Singapore Sculpture Award in 2003. It signifies boldness and strength in the face of harsh environmental conditions. The design was inspired by resilient reed plants often found standing tall in water or in dry places.

This public art work was commissioned by CDL and sited at Robertson Quay in conjunction with the National Heritage Board's Public Sculptures Scheme.

The work is designed by Peter Chen, an architect by training. He is currently assistant professor at Nanyang Technological University's School of Art, Design & Media (ADM), where he teaches 3D foundation studio. The NTU ADM is the first comprehensive professional art school in Singapore where students are equipped with the knowledge and tools to produce ground-breaking creative artworks.

Background & Objectives

The CDL Singapore Sculpture Award was first initiated in 2003. Its objectives are:

[1] to enhance the appreciation of and the standard of sculpture in Singapore;

[2] to recognize and showcase the talent of both established and aspiring sculptors;

[3] to inspire young artists to develop their interest and potential in this art form

If appropriate and relevant, CDL will commission and produce the winning work into a life-size sculpture for public display. It will allow for young artists to have their work publicly displayed.

This Award reinforces CDL's long-standing commitment in supporting the development of the arts and youth in Singapore. There is an exhibition of winning and selected interesting works at the Singapore Art Museum.

NHB Expands Scope of Tax Incentives for Public Artworks

25 January 2007 marks the launch of City Development Limited's "Reed Sculpture" at The Pier at Robertson Quay. The unveiling of this magnificent piece of art work created by Mr Peter Chen is highly significant as it marks the first donation under the Public Art Tax Incentive Scheme (PATIS).

Following closely behind CDL's fine example of commissioning works of art for public enjoyment is Ascendas. The company, which developed and manages the Phase II of Biopolis research facility at North Buona Vista Road, has recently commissioned art works to enhance the environment. These works are created by renowned artists Ms Lee Meiling, Mr Kenneth Tan and Mr Vincente Delgardo (Tito).

PATIS was formerly known as the "Public Sculptures Scheme (PSS)". Its name was changed to reflect the wider scope of the scheme to include both twodimensional and three-dimensional works. This change is intended to encourage the display of more forms of public art beyond sculpture.

To qualify for PATIS, artworks should have artistic and/ or heritage merits, and be displayed in a publicly accessible or publicly visible area. Under the scheme, donors who commission, display or adopt a public artwork can enjoy a double tax deduction off the value of the artwork, or costs of installation and maintenance.

Approved recipients eligible for PATIS donations should be public agencies or owned by public agencies. Under the revised scheme, the definition of a "public agency" has been expanded. It now includes non-profit arts and heritage institutions whose subscribing members and Board of Directors are appointed by the Minister or Permanent Secretary of a ministry. This allows for more institutions to qualify as approved recipients of donations.

PATIS is one of three tax incentive schemes administered by the National Heritage Board (NHB). The others are the National Heritage Fund – Central Fund (NHF-CF) and Approved Museum Scheme (AMS). From FY03 to FY05, a

total of almost \$41 million worth of cash and artefact donations was channeled through NHB.

NHB also lends support to the Urban Redevelopment Authority (URA) for the URA Gross Floor Area Incentives. It provides secretariat support for the Public Art Appraisal Committee (PAAC) which together with URA jointly appraises and endorses artworks under consideration.
