M&C REIT Management Limited, as manager of H-REIT (the "**H-REIT Manager**"), and M&C Business Trust Management Limited, as trustee-manager of HBT (the "**HBT Trustee-Manager**", and together with the H-REIT Manager, the "**Managers**"), wish to announce that out of the remaining gross proceeds of the Rights Issue of S\$103.7 million, approximately S\$101.9 million (which is equivalent to approximately 39.9% of the gross proceeds of the Rights Issue) has been used to fully repay the amount outstanding under the US\$75.0 million term loan facility.

The above use is in accordance with the intended uses of the Rights Issue as stated in the OIS.

The Managers will make periodic announcements on the utilisation of the remaining proceeds of approximately S\$1.9 million via SGXNET as and when such funds are materially utilised and provide a status report on the use of the proceeds from the Rights Issue in the annual reports of CDLHT.
